



ROGERS GARDENS CAMPGROUND

RULES & REGULATIONS

- 1. ALL VEHICLES MUST HAVE A VISIBLE PASS. BE PREPARED TO STOP AT THE GATE WHEN YOU ENTER ONTO THE PROPERTY TO ALLOW OUR STAFF VERIFY THE STICKER ON YOUR VEHICLE.**
- 2. VEHICLES, TENTS, SLIDE OUTS, RV's, CAMPFIRES AND GENERATORS MUST FIT ON YOUR ASSIGNED SITE.**
- 3. IF YOUR VEHICLE WILL NOT FIT ON YOUR ASSIGNED SITE, THEN IT MUST BE PARKED IN OUR OVERFLOW PARKING AREAS. ASK AN ATTENDANT FOR ASSISTANCE AS THESE DESIGNATED PARKING AREAS CHANGE FROM RACE TO RACE. PLEASE DO NOT BLOCK THE ROADWAYS AS THEY MUST BE OPEN FOR EMERGENCY SERVICES.**
- 4. GENERATORS ARE ALLOWED. WE JUST ASK THAT YOU KEEP YOUR NEIGHBOR IN MIND. IF YOUR GENERATOR IS LOUD AND WOULD DISTURB OTHERS, WE ASK THAT YOU MUFFLE THE NOISE WITH FOAM BOARD OR SOMETHING AND DO NOT RUN ALL NIGHT. PLEASE BE MINDFUL OF WHERE YOU DIRECT YOUR GENERATOR EXHAUST. WE RECOMMEND ALL CAMPERS HAVE A WORKING CARBON MONOXIDE DETECTOR IN THEIR RV / MOTOR HOME / CAMPER.**
- 5. CAMPFIRES ARE ALLOWED, BUT MUST BE CONTAINED INSIDE A RAISED FIRE RING. DO NOT BURN ANY PALLETS OR WOOD WITH NAILS. PLEASE CLEAN UP YOUR FIRE PIT WHEN YOU LEAVE. PLEASE DO NOT DUMP ASHES IN TRASH DRUMS OR DUMPSTER. WE HAVE AVAILABLE METAL DRUMS TO DUMP YOUR ASHES. FOR YOUR SAFETY AND THE SAFETY OF THOSE ROUND YOU, PLEASE HAVE A FIRE EXTINGUISHER HANDY, JUST IN CASE.**
- 6. MOST PETS ARE ALLOWED, BUT STRICT LEASH LAWS ARE IN EFFECT. ANY PETS MUST HAVE CURRENT RABIES VACCINATIONS. PLEASE CLEAN UP AFTER YOUR PETS. PETS WHICH ARE PROHIBITED INCLUDE SNAKES & ANY DOGS WHICH HAVE BEEN TRAINED OR BRED TO FIGHT.**
- 7. SPEED LIMIT THROUGHOUT THE CAMPGROUND IS 10 MPH.**
- 8. QUIET HOURS ARE 1:00 A.M. THROUGH 6:00 A.M.**
- 9. EVERYONE IS HERE TO HAVE A GOOD TIME. PLEASE BE RESPECTFUL OF YOUR NEIGHBOR AND DO NOT GET TO LOUD. AFTER 1:00 A.M. NOISE LEVEL MUST BE AT A MINIMUM. LOUD CURSING, FIGHTING AND ANTAGONISTIC BEHAVIOR WILL NOT BE TOLERATED AND WILL RESULT IN INSTANT EXPULSION FROM THE CAMPGROUND. OUR SECURITY WILL CALL THE POLICE IF NECESSARY. IT IS OUR INTENT TO KEEP OUR CAMPGROUND AS SAFE, SECURE AND FRIENDLY AS POSSIBLE. WE ASK THAT EVERYONE RESPECT THESE RULES AND HAVE A WONDERFUL TIME.**
